Rea	-do you see the irony of plotting to kill someone but not wanting to be "defiled"
	5. Defiled so that they would not be able to "eat the Passover"

Rea	-what are the charges?
	-probably anticipated a serious charge

	-in other gospels He is accused of opposing taxes and claiming to be Messiah
Rea	-is it just me, or do you hear a bit of smart aleck attitude in these who delivered
	Jesus well of course there are charges!
	-threatened

	9. You take Him and judge Him (verse 31)
	-we cannot put Him to death
	-"Jews" are chief priests and Sanhedrin council
	-capital punishment was not allowed by their "law"
Rea	-so, by the use of the word "death" you see where they want to go with this
Rea	-also, sounds to me as if they had this answer waiting knowing what Pilate
	might say - Satan is clever
	10. The Scripture is fulfilled by their statement - see John 3:14 and Dt. 21:23 (verse 32)

	-are you the King of the Jews?
	-interrogated by Pilate, not lawyers (like our system of justice)
	13. Jesus' words (verse 34)
	-are you saying this? Or someone else?
	-He challenges the thinking about the charges brought
Rea	-He also clarifies for us what Jesus was about not an earthly kingdom - not even
	in 2023

	14. Am I a Jew? (Verse 35) - your own nation has brought you here
	-if these wanted Him crucified he assumed there was a reason
	-what have you done?
Rea	-a straightforward question from a person who is more unbiased that the Jewish
	leadership. The Jewish leadership sought to use the law to get their way. Always,
	laws may be twisted and turned - notice in our day how lawyers do it.
	15. My kingdom is not of this world (verse 36)
	-He does not deny being king - but not a king of this world
